Eligibility Criteria :-


1. Candidates must be Indian citizen as defined in Articles 5-8 of the constitution of India.
2. Candidates already in service should apply through proper channel.
3. Age of the candidates should not be less than 18 years and not more than 38 years as on 1st day of January, 2021. Upper age limit relaxation of 5 years for SC & ST candidates and for those candidates who are in Department Service and 2 (Two) years for Ex-Servicemen.
4. The application with attested copies of testimonials regarding Qualification, age, Employment Exchange Registration card, etc. along with 3 (Three) copies of recent Passport size Photographs duly signed by the candidate should reach in the office of the undersigned on or before 27/09/2021 during office hours.
5. No application will be received through Post. The intending candidate will have to submit his application in person at the office of the undersigned during office hours on or before 27/09/2021
6. Short listed candidate for the post of office Chowkidar will be called for a Viva Voce (Oral) and date of Viva(Oral) will be mentioned in the Calling letter to be issued to the candidate. All original testimonial will be scrutinized before the Viva Voce.
