

ADVERTISEMENT

The District Fishery Development Officer, Dima Hasao invites application from any community groups for the project 'Construction of Village Community Tank with fish culture inputs for the first year' under the scheme Fishery Mission Society-Chief Minister's Samagra Grammya Unnayan Yojana (FMS-CMSGUY).

Terms and conditions are laid for the project:-


- a. Average pond size (Water spread area) for each project : 1.00 ha
- b. Average land size for each project : 1.38 ha
- c. District Target: For Dima Hasao : 5 numbers
- d. All community groups including Farmer Producer Company (FPC), Farmers Producer Group (FPG), Farmers Producer Organization (FPO), Self Help Group (SHG) and NGOs etc. having land in their ownership, lease, donated and Govt. land shall be eligible for assistance upto maximum 1 ha (water area) only. The cost of construction of community pond over and above 1 ha water surface area shall be borne by the community group.
- e. The land applied for the scheme should belong to village community, religious institutions like Satra, Temple, Namghar, School, College, Clubs etc. or Govt. Khas land under possession by such community.
- f. The land owned by community group by means of lease agreement, should be for a period not less than 7 years effective from 1st January of the year of approval.
- g. Individual land of single Pattadar, but taken on lease by a group of people/unemployed/SHGs shall not be less than 10 years. In this regard the beneficiary shall furnish a registered deed (non-transferrable) in terms of lease agreement.
- h. The community group or the committee who occupied the land, particularly Govt. khas land shall apply with supporting documents such as resolutions of the general body meetings, by-laws, possession certificate etc. In case of Govt. khas land, a Clearance /No-Objection Certificate from the concerned Circle Officer / DC is essential.
- i. The Community/Groups/Social institution must submit no objection certificate (NOC)/Notary Affidavit as well as Willingness Certificate (WC) to implement the scheme by their Executive Committee.
- j. The community/groups/social institution must be free from internal conflict/social conflict for utilization of their land for the said fishery (s) and the land must be encumbrance free.
- k. Must be ready to submit a court affidavit to the Dept. of Fisheries , Assam prior to starting of the scheme by stating that if implementation of the scheme is ceased under any circumstances before completion and after investment of a part of the approved fund, then the community/groups/social institution will refund the already invested amount to the Govt. (****Notary Affidavit****)
- l. The Community group or committee shall agree to contribute their (if any) for completion of the project as per plan and estimate.
- m. The minimum order of bonafide members in a community/group shall not be less than (ten) members.
