The Quotation will be received upto 2pm on 9th August /2023 and will be opened on the same day at 3Pm in presence of the quotationer or their representatives. The rate quoted must be inclusive of GST or any other taxes levied by the Government of Assam from time to time. The actual quantity of supply item will be inform to successful quotationer /bidders later on.

Term and Condition:-

1. The feed should contain at least 25% Protein 20% Carbohydrates and 5% fats with minimum digestible energy of 280 K cal/100 gm.
2. The feed should conform to ISO/ISI specification/No.
3. Feed quality to be certified by any ICAR institute/ Agriculture Universities.
4. The supplier is to supply the feed in 2-3 (two-three) instalments at the office of District Fishery Dev. Officer as per requirement .
5. The quotationer should quote the rate for the item including transportation cost. Packaging cost & delivery cost. No extra amount will be borne by the Department.
6. The item after supply if not found conforming as per specification will be summarily rejected.
