Sir/Ma'am,

In inviting a reference to the subject cited above, I am to inform you that in the last VC held under the chairmanship of the Hon'ble Chief Minister it was learnt that the performance of the district towards containment of COVID-19 was not satisfactory at all. Hence, we have been directed to implement stricter measures for further containment of the disease.
