2. The Feed should contain at least 25% Protein 20% Carbohydrates and 5% fats with minimum digestible energy of 280 K cal/100gm.

4. The tenderer quoted rate for the item should be included transportation cost, packaging cost & delivery cost. No extra amount will be borne by the Department.
